DEPARTMENT OF SCHOOL EDUCATIONS - DFT CIRCULAR - REGARDING POCSO / ANTICORPORAL PUNISHMENT

All the staff members are requested to adhere to the child protection policies of the school. Staff are requested to strictly maintain healthy distance from girl students. Be quite professional in your attitude and avoid unpleasant situations. You're not allowed to comment on our students, pat/fondle them, exchange phone numbers, gifts or compliments. Be aware of the incidents in context with exposure of pornographic representations in any form. If any child reports on such incident, the staff will be imprisoned for a period of six months and ever will be terminated from service immediately. All these cases are under POCSO Act which is non-bailable offense.

Parents are quite particular that even kindergarten girl students are not to be pampered or touched by male staff, drivers, PETs etc. Laws are stern that no one can support you even if it is a manipulated case. Let us be mindful of our actions. The law cffers all sorts of priority and security to the victims in spirit of evidence. The school has various initiatives to collect reports on teacher's approach towards students. If any case is reported against any teacher, he/she will be terminated from service without any delay. No grievances will be accepted post incident. It is your sole responsibility to be away from all sorts of controversies. At this moment, let us update ourselves with POCSO ACT and its legal sides.

POCSO or The Protection of children from Sexual Offenses Act (POCSO Avt) 2012 was established to protect the children against offense like sexual abuse, sexual harassment and pornography. It was formed to provide a child friendly system for trial underneath which the perpetrators could be punished. Cases under POCSO Act is non-bailable offense and severe actions will be initiated.


